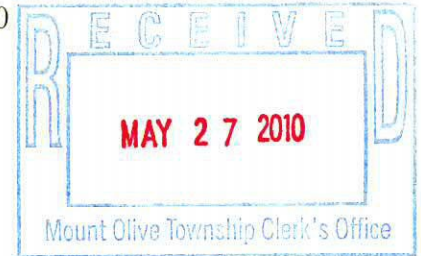


TAKE NOTICE that the following claim is hereby presented under the New Jersey Tort Claims Act on behalf of Robert DeSanno.

- a. The claimant is Robert DeSanno residing at 43 Eagle Rock Village, Budd Lake, NJ 07828.
- b. Any notice with regard to this claim should be directed to the firm of Heymann & Fletcher, in particular to Ronald S. Heymann, attorneys on behalf of the claimant. The address is P.O. Box 518, Mt. Freedom, NJ 07970.
- c. This claim arises out of a collision between the claimant Mr. DeSanno and William Gremmo, a police officer employed by the Township of Mt. Olive, and Catherine A. Krizni of 213 Sandshore Road, Budd Lake, NJ. Said accident occurred at the intersection of Rt. 46 and Woodsedge Avenue ON May 1, 2010.
- d. Damages claimed: shoulder injury, injury to left hand, disc bulge at L5-S1, disc herniation at L5-S1, disc herniation at C4-5 and C5-6.
- e. The damages to claimant were caused by the negligent operation of the police vehicle by the Township of Mt. Olive police officer whose name is William Gremmo.

f. Claimant Robert DeSanno is still undergoing treatment and at this point in time we do not have a detailed amount of damages to present.

g. As a consequence of claimant's injuries claimant may lose income in the future.

h. As this point we do not make a demand for damages.
