

**RESOLUTION OF THE TOWNSHIP COUNCIL OF THE TOWNSHIP OF MOUNT OLIVE AMENDING THE 2008 TEMPORARY BUDGET FOR THE CURRENT FUND**

**WHEREAS**, an emergent condition has arisen with respect to inadequate funds being provided for in the temporary current budget and NJSA 40A:4-20 provides for the creation of emergency temporary appropriations for the purpose mentioned above, and

**WHEREAS**, the total emergency temporary resolutions adopted in the year 2008 for the current fund pursuant to the provisions of Chapter 96, PL 1951 (NJSA 40A:4-20) including this resolution total \$11,343,603 for the current fund, \$575,350 for the water utility, \$1,809,125 for the sewer utility, \$1,324,370 for the sanitation district and \$189,590 for the recreation utility.

**NOW, THEREFORE BE IT RESOLVED** that the attached appropriations are hereby amended and approved by the Township Council of the Township of Mount Olive and the Chief Financial Officer, Sherry M. Jenkins, is directed to make the appropriate financial entries.
