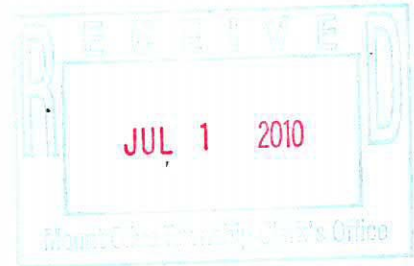

Dear Ms Abraham:

On June 11, 2010, a Representative of the Department's Bureau of Coastal and Land Use Compliance and Enforcement ("Bureau") conducted an inspection of the above referenced site. The purpose of the inspection was to assess compliance with the Bureau issued Notice of Violation ("NOV"), dated January 10, 2010. The inspection revealed that you have complied with the corrective actions contained in the NOV and this enforcement case is hereby resolved.

Any future disturbance or alteration of this area may constitute a regulated and/or prohibited activity and require a permit from the Department. In addition, the Department reserves the right to take enforcement action should a permit violation, regulated and/or prohibited activity occur on the site without the necessary approvals.

Should you choose develop the site, in accordance with the conditions contained in the Individual Permit Transition Area Waiver ("IPTAW") 1427-05-0009.1 FWW 060001, you must first notify this office 7 days prior, and install and maintain the appropriate silt and construction fences. The Bureau anticipates conducting routine compliance inspections throughout the duration of the permit and will require strict compliance with the approved limits of disturbance and all conditions therein.

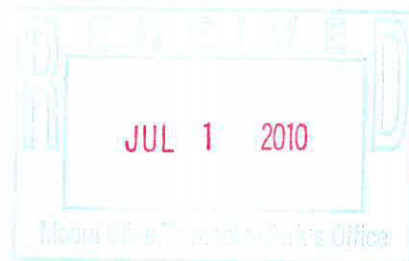
