

**RESOLUTION OF THE TOWNSHIP COUNCIL OF THE TOWNSHIP OF
MOUNT OLIVE RELATIVE TO MOUNT OLIVE CARNIVAL WEEK (7/23/08-
7/28/08) AND MOUNT OLIVE COMMUNITY WEEK WITH FIREWORKS
SCHEDULED FOR (7/26/08)
AND RAIN DATE (7/27/08)**

WHEREAS, the Township's Recreation Department is planning what is to be known as the Mount Olive Carnival week which will be conducted between July 23rd and July 27th as well as Mount Olive Community week which is scheduled for July 23-27th with fireworks scheduled for July 26th with a rain date of July 27th and fireworks are scheduled for ~~10 p.m.~~ 9:15pm on July 26th or the rain date of July 27th; and

WHEREAS, it is necessary to make some significant restrictions as to parking during these events and to waive certain other restrictions so that the programs may go forward.

NOW, THEREFORE, BE IT RESOLVED, by the Township Council of the Township of Mount Olive as follows:

1. The hours of operation of Turkey Brook Park shall be extended from sunset to 11:45 p.m. from Wednesday, July 23rd through Sunday, July 27th.
2. The Noise Ordinance which is applicable under normal circumstances shall be waived from a 10 p.m. deadline to an 11:45 p.m. deadline on Wednesday, July 23rd through Sunday, July 27th as the carnival continues until each evening until 11 p.m. Noise may continue until 2 am on July 29th as the Carnival breaks down.
3. Certain parking restrictions are necessary and appropriate under the circumstances and those restrictions are as follows:
 - a. Parking shall be restricted, limited, or prohibited, as directed or posted by the police department on local streets for the duration of this event, i.e. from 5 pm to 11 p.m. on July 23rd through the 25th , and from noon to 11 p.m. on July 26th and July 27th.
 - b. There shall be no parking on Sunset Drive from 5 p.m. to 11 p.m. on July 23rd through the 25th and from noon to 11 p.m. on July 26th and July 27th.
 - c. Parking shall be restricted, limited, or prohibited, as directed or posted by the police department in Gold Mine Estates, from 5 p.m. to 11 p.m. on from July 23rd through the 25th and from noon to 11 p.m. on July 26th and July 27th.

- d. Wynnewood Avenue between Clinton Avenue and Flanders Road, and, Chelsea Avenue between Clinton Avenue and Flanders Road shall be closed to vehicular traffic on July 26th or on the rain date of July 27th, between 4 p.m. and 11:00 p.m. either day.
- e. Parking shall be restricted, limited, or prohibited, as directed or posted by the police department, on Pershing Avenue, Washington Street, Delbar Drive, Summit Avenue, Stanley Place, and Carson Road from 5 p.m. to 11 p.m. on from July 23rd through the 25th and from noon to 11 p.m. on July 26th and July 27th.
