GENERAL INFORMATION

The Township of Mount Olive is located in northwestern Morris County and is bordered by Sussex and Warren Counties. With an area of over thirty-two (32) square miles, and a population estimated at 25,718 it is one of the most rapidly growing communities in Morris County and New Jersey. Mount Olive residents enjoy easy access to the major transportation roadways, Interstate 80, Routes 46 and 206 that traverse the Township, yet reside in a tranquil rural-suburban atmosphere.

A Mayor/Council form of local government was established by Charter in 1970. This provides for a Mayor who is the Chief Executive Officer of the Municipality, and who is responsible for the administration of the local government. A seven (7) member Council, elected at large, serves as the legislative body. The Charter provides for the Mayor to appoint a Business Administrator to supervise the day-to-day operation of the Township. In addition, the Mayor appoints the Directors of the various Township Departments. Those professionals, along with the Mayor and Council, are responsible for directing Mount Olive's future growth in a manageable and environmentally sound manner, so that the qualities that make Mount Olive a desirable place to live and to work remain intact.

HOME IMPROVEMENTS - PERMITS

Mount Olive utilizes the Basic Building Code (BOCA). Permits are issued within twenty (20) business days of submitting a completed application to the Construction Code Official. Certain setbacks and constraints apply to the permit. For additional information contact the Construction Code Official. Building permits are required by the Township, but not limited to the following: new construction, additions, structural alterations, swimming pools, temporary uses and structures, storage sheds, fences. Prior to the issuance of a building permit or a certificate of occupancy, it is necessary to secure a zoning permit to confirm compliance with the Township's land use regulations. CERTIFICATES OF HEALTH

ANIMAL CONTROL

It is unlawful for any person to permit any animal to run at large upon any public thoroughfare, upon any public ground or to run at large on any private property other than that of the owner. Dog licenses are to be renewed during the month of January and cat licenses are renewed during the month of April each year in the Health Department. Failure to obtain a license at the appropriate time will result in late fees being charged to the animal owner. Proof of rabies vaccination is needed to obtain the license and there is a discount if the animal has been spayed/neutered. Mount Olive Township provides a spring and fall rabies clinic. RECYCLING INFORMATION

Mount Olive is reducing its waste through a comprehensive curbside recycling program. Curbside collection is provided to all homeowners serviced by the Department of Public Works. Recyclables are collected at the same time as your regularly scheduled garbage pick up. New residents should call the Department Public Works to find out what day of the week their garbage is collected. Consult the Town Planner calendar for alternate holiday collection days as well as for information regarding recyclables and large item pick-up or contact the Department of Public Works. Residents may deposit recyclable materials behind the Municipal Building on Flanders-Drakestown Road. **The Recycling Center is open Monday thru Friday 8:00 a.m. to noon and Saturday from 8:00 a.m. to 3:00 p.m., closed Sundays and Holidays.
